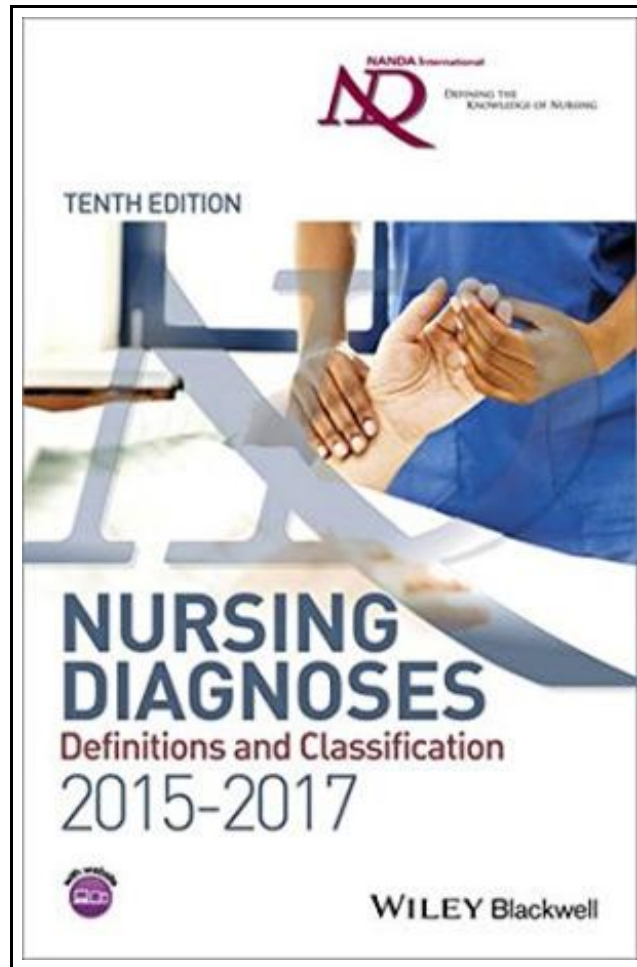

Five nursing diagnoses have been re-slotted within the NANDA-I taxonomy, following a review of the current taxonomic structure.
